

The board of Trustees for smooth running of the objects of the trust may also appoint any person/persons as Additional Trustee/Additional Trustees for a period of maximum three years from the date of his/her/their appointment. But such Additional Trustees shall member/members of the Board of Trustees and also shall not have

Trustees shall be eligible for reappointment after the expiry of his/her/their three years term. Further if the work of such additional trustee/additional trustees is not found satisfactory by the expiry of his/her/their term. The decision of the Board of Trustees shall be final in this respect and cannot be questioned in any court of Law.

(e) If the trustees hereby appointed or any of them or any further trustees or trustees hereof shall be or go to reside abroad for more than two consecutive years or shall desire to retire or resign from or refuse or become incapable to act in the trusts of these presents or become insolvent then it shall be lawful for the trustees of these presents or for the surviving or continuing trustee/trustees then for the retiring or refusing trustees/trustees in place of the trustee/trustees so doing or going to reside abroad for refusing or resigning or becoming unfit or incapable of acting or being adjudged insolvent as aforesaid.

The Trustees shall be entitled for only such incidental and/or out of pocket expenses which may have been actually incurred by them while carrying out the objects of the trust as per rules and regulations to be framed by the Board of Trustees from time to time in this regard. This power shall be regulated by Chief Managing Trustee as per need

Election of Trustees and its working period-

The Trustees shall elect from amongst themselves one chairman / Chief Managing Trustee and one managing trustee who shall hold office forever unless he resigns or refuses to act as chairman/managing trustee or other wise ceases to be a trustee. The retiring Chairman/ Chief Managing Trustee, however, shall be eligible for re-election. The chairman shall preside at all meetings

10. The trustees shall by majority confer on the Chairman/ Chief Managing Trustee such powers as they may think fit. The trustees shall also have the power to withdraw the same by majority if they think fit to do so. It shall be approved by Chief Managing Trustee.

11. Four trustees for the time being shall form a quorum for any meeting of the Board of Trustees. The Managing Trustee shall call

the meeting always as per need of the Trust.

12. Every power or authority or discretion conferred upon the trustees shall be exercised or signified either by some instrument in writing signed by the Chairman / Chief Managing Trustee or minimum by four trustees or by resolution of the trustees passed in their meeting or by circulation.

Difference of Opinion Among Trustees-:

13. In case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have discretionary

Management of Account:

14. The trustees shall keep or cause to be kept proper books of accounts and the annual accounts of the trust shall close on every 31. Day of March. And shall be audited by the chartered Accountant and should be produced before the Board of Trustees within six months from the date of close of financial year, that is 31st. of March every year.

Information of meeting of Board of Trustees:-

15. Notice of the meeting of the Board of trustees and all communications shall be sent to the trustees at their addresses on the records of the trust either by regd. Post or by due acknowledgment of personal delivery and the meeting of five

16. The minutes of the proceedings of every meeting of the Board of Trustees shall be entered in a book to be kept for that purposes and signed by the chairman of such meeting or of the following meeting when the same is read over and confirmed and so signed and entered shall be conclusive proof of business and other matters transacted at such meeting.

Settlement of Decision of Board of Trustees in the meeting-:

17. All proceedings, questions and matters arising at any meeting of the Board of Trustees shall be decided by a majority of votes and in case of equality of votes the Chairman have second of costing vote.

Delegation of power of Trustees:-

18. The trustees may delegate any power to one or more of their body(trustees) and may also withdraws the same after approval of Chief Managing Trustee.

19. The Mode of Transaction of Money and Bank Accounts:-

20. The Chief managing trustee His Highness Madhur Ji Maharaj Suprabhat Dwivedi is most superior personality in social and spiritual manner hence for delivering the religious lectures he visits and will have to visit in India and other countries thus for smooth functioning of the trust the power of Chief Managing Trustee shall be shifted to managing trustee automatically.

Investment of Fund in Respect of movable Property:-


